Monetary Award Program (MAP)

- Spring (second-term) payment requests may be submitted in the MAP system
- The payment claim deadline date for the second-term will be announced once it has been determined.
- Fall (first-term) claims are still being accepted even though the deadline date was Friday, December 8, 2023
 - Any first-term claims made after the deadline date are considered late and will only be paid if funding is available after paying timely claims.
- Payment requests are processed on a nightly basis and results are provided the next business day.
- ISAC suspended the announcement of 2023-24 MAP awards for students whose initial 2023-24 FAFSA[®] or Alternative Application was received on or after September 23, 2023.


Nursing Education Scholarships (NES)

- Letters of eligibility have been sent to students who were awarded
- Colleges can see an award date and maximum annual award amount on their Student List in the NES system in GAP Access
- 2023-24 NES maximum award amount is either \$8,916 or \$17,813
- The certificate, diploma or degree being pursued by the recipient determines the NES maximum award amount, along with the type of college
- Maximum award amounts are based on full-time enrollment and include a living allowance
- The living allowance component of the award is only available to students who are enrolled full-time according to the school/program's definition of fulltime status
 - For 2023-24 awards, the maximum living allowance is \$5,200



NES Award Determination

- Based on certification data submitted by the college, ISAC completed the awarding process and has sent the appropriate notification to each applicant.
 - Eligible Funded students who are eligible for the award
 - Eligible Unavailable Funds students who are eligible for the award, but for whom funds are not available
- Applicants determined to be ineligible for the award received a Notice of Ineligibility letter
- Samples of the letters are provided in the NES section of the FAA area of isac.org



Award Determination for Nursing Education Scholarships

{ISAC Rules, Section 2749.220}

Overview

Student Award Announcements Award Amount and Years of Funding

The total number of scholarships awarded each year is contingent upon the the Illinois General Assembly.

All timely applicants whose colleges or universities have certified their eligibil ISAC receipt date are included in each academic year's awarding process.

When appropriated funds for this program are insufficient to provide scholars applicants during any fiscal year, available funds will be awarded to qualified complete timely applications (i.e., the complete NES application is submitted based on the following priority order:

 Scholarships will first be awarded to *renewal applicants* who continue to program's eligibility requirements. An applicant is considered a renewal a previous academic year, they received funds from the program for which applying.

Note: to the extent that the applicant pool allows, the following is the priority order used to determine awards for *new applicants* within each of the above categories:

- 1. Lowest to highest expected family contribution (EFC), as determined by the Free Application for Federal Student Aid (FAFSA®) or the Alternative Application for Illinois Financial Aid (Alternative Application)
- 2. Anticipated graduation date for current program of study
- 3. Date on which complete NES application was received by ISAC

Student Award Announcements

Based on the eligibility certification data submitted by the college, as well as the above factors, ISAC proceeds with the awarding process and sends the appropriate notification to each applicant.

ISAC sends eligible NES applicants one of the following notifications:

- Eligible Funded students who are eligible for the award
- Eligible Unavailable Funds students who are eligible for the award, but for whom funds are not available


Applicants determined to be ineligible for the award receive a Notice of Ineligibility, and have the option to appeal the denial.

2. If funds remain after all qualified renewal applicants have been awarded, then awards will be made to eligible *new applicants* in the categories listed below:

Degree Types	Approximate Percentage of Available Awards
Graduate Degree in Nursing Graduate Degree in Nursing (to become a Nurse Educator)	20%
Baccalaureate Degree in Nursing	40%
Associate Degree in Nursing Hospital-based Diploma in Nursing	30%
Certificate in Practical Nursing	10%

- The amount of your award will include a portion of your tuition and fee costs, plus, if eligible, a living allowance (previously referred to as a stipend). Contact the financial aid office of your college for the exact amount.
- Your college will verify your enrollment and the eligibility of the program in which you are enrolled.
- If your college determines you are not eligible, you will receive a Notice of Ineligibility after your college reports your status to ISAC.
- Questions about your eligibility and the disbursement of funds should be directed to the financial aid office of your college.
- If you fail to meet any of the eligibility requirements during the academic year, the entire scholarship ٠ or a portion of the scholarship funds may be forfeited.
- By receiving any or all of this scholarship, you agree to fulfill the work commitment that is outlined on the application/grant agreement/promissory note. If this work commitment is not fulfilled within the required time for the program, the amount awarded converts to a loan that must be repaid with interest.
- You are obligated to report any changes to your name, address, college of attendance or enrollment status to ISAC within ten days of the change.

NURSING EDUCATION SCHOLARSHIP NOTICE OF INELIGIBILITY

Next Steps:

- It is your responsibility to report changes or corrections regarding your eligibility status to your college. Certification of your eligibility must be submitted to ISAC directly from the college. A change in eligibility status does not guarantee that you will receive an award. If, after working with your college to process any corrections, you wish to appeal this decision, you must submit a written appeal to ISAC within 60 days after the date of this letter. Refer to the enclosed "ISAC Appeal Procedures."
- You must immediately notify ISAC, in writing, of any changes to your permanent address, phone number, and/or your request to be considered for this scholarship.
- If the above-named college is not the college you will attend, you must submit a request to ISAC to change your college choice. If this change would impact your eligibility status, ISAC will contact the new college for updated certification information.
- All ISAC scholarships are limited based on the number of eligible applicants and funding availability. Therefore, you are encouraged to continue seeking additional financial aid resources to fund your educational expenses.

- Schools may submit payment requests (claims) for the fall, winter and spring terms in the NES system in GAP Access
- Priority claim deadline dates for each term will be announced once they have been determined.
- By submitting a payment request, schools are certifying that the student meets all eligibility criteria.
- If an awarded student becomes ineligible, schools will need to provide an ineligible reason from the drop-down menu.
- Payment requests are submitted for individual students by term.
- Payment requests are processed on a nightly basis every weekday, with results available the following business day.



- Only students who have been awarded will appear on the Student Payment List: View screen.
- When requesting payment for a student, the college must indicate the student's enrollment status, and then indicate separate amounts to be designated for tuition and fees charges, as well as the living allowance for a full-time student.
 - Fees are defined as those that all students enrolled in a nursing program must pay, including required course or lab fees.
 - The living allowance may be used to cover room and board living expenses, miscellaneous fees, books, transportation, and commuting costs.
- The NES system will then calculate the total amount payable to the student for the term, up to allowable maximum award.



- Students at semester schools may receive two disbursements (fall and spring terms)
- Students at quarter schools may receive three disbursements (fall, winter and spring terms).
- When a student is receiving enough financial aid from other sources to meet a term's cost of attendance, NES funding can be requested in a subsequent term
- For students who are receiving other aid and who may not use their total NES annual award during the fall, winter or spring terms, an option to disburse an award for the summer term will be added to their record in the NES system following the spring term.



- If the student will not be enrolled for the full award year (e.g., the student is graduating at the end of the fall term), the student may receive the full maximum annual award amount up to the student's cost of attendance for the term enrolled.
- Or, in cases where a recipient's eligibility may not be determined until later in the award year, multiple disbursements are not required, and the system will allow the college to request up to the maximum annual award amount in a term.
- When packaging NES with other financial aid that students may have available to them, keep in mind that the NES program has a nursing employment obligation that must be met after completing their degree or program
 - Which is why this program is intended to be used after other assistance that does not have an obligation associated with it has been applied.



- Payment results will display on the NES Student Payment List: View screen or the NES Student Detail: Payment screen the day after payment requests are processed.
 - A Payment Result Summary and Invoice Detail Report can be viewed or printed by selecting the Report tab in the NESP system
- Payment requests will be disbursed to the college in one lump sum, so that NES funds can be credited to student accounts rather than as individual checks for each student.
 - $_{\circ}~$ Funds are issued by the State Comptroller directly to the institution
 - They are provided electronically or as a check, depending on how the college is set up
 - Reports for tracking payment vouchers and warrants are available via the NES system
- Payment offset and reconciliation procedures apply to NES program
 - Cancellations/adjustments to payment requests (claims) made throughout the award year will offset additional payments to the college during the year.
 - Refund checks should not be sent throughout the award year.



- Upon receipt of the scholarship funds from the Comptroller, the college should verify the student's enrollment status for the term for which the award was intended.
- If the recipient is enrolled, the institution may credit the scholarship funds to the recipient's account for expenses due and payable, and if appropriate, any balance is to be returned to the recipient.
- If the recipient has withdrawn and funds must be returned, the college should indicate that reason on the NESP Student Detail: Payment screen.





- In addition to the applicant data, the Student List Eligibility: View screen includes the application complete status and icons to indicate eligibility issues.



Program Funding

The 2024 fiscal year (July 1, 2023 – June 30, 2024) appropriation for Nursing Education Scholarships (NES) is \$4,000,000.

Payment

Important dates and reminders for 2023-24 NES payment processing:

- As part of our ongoing efforts to best leverage appropriated funds to award as many eligible students as possible, priority payment request (i.e., claim) deadline dates are established for each term.
 - ISAC is accepting 2023-24 NES claims for the fall, winter, and spring terms.
 - The priority claim deadline dates for the fall, winter and spring terms will be announced once they have been determined.

ECACE Scholarship

- Schools may submit claims for the spring semester and winter quarter (second-term) and spring quarter (third-term).
- Priority claim deadline dates will be announced once they have been determined
- Fall (first-term) claims are still being accepted even though the deadline date was Friday, December 29, 2023
 - Any first-term claims made after the deadline date will be considered late and will only be paid if funding is available after paying timely claims.
- Schools are encouraged to complete and submit payment request data as soon as possible.



ECACE Scholarship

- By submitting a payment request, a college is certifying that the student meets all eligibility criteria.
- If a college determines that a prequalified applicant does not meet all eligibility requirements, report the reason that best describes the reason for ineligibility.
- Colleges will be notified when ISAC begins accepting ECACE claims for the summer (fourth term).
- ECACE is payable in a summer term if the student has not used their maximum award amount in previous terms.



Minority Teachers of Illinois (MTI) Scholarship Program

- Schools may submit claims for the spring semester and winter quarter (second-term).
- The second-term priority claim date will be announced once it has been determined.
- Fall (first-term) payment requests are still being accepted even though the priority claim date was Friday, December 29, 2023.
 Any first-term claims made after the deadline date will be considered late and will only be paid if funding is available after paying timely claims.
 - An MTI recipient who is also eligible for a MAP grant may use the MAP award first for tuition and mandatory fees.



MTI Program

- Students cannot receive program benefits from two ISAC teacher programs (MTI, GA, SETTW) in the same award year
 - Indicators are provided in GAP Access when students have been determined eligible for other ISAC teacher programs
 - If a student is awarded for more than one teacher program, schools should work with the student to confirm which award they want to accept
- ISAC continues to do additional rounds of MTI awarding
- Be sure to review student records for any conflicts of dual awarding of ISAC teacher programs before requesting payment




MTI – Identifying Bilingual Applicants

- How to identify applicants who indicate on their application that they are bilingual in the MTI system with GAP Access
 - The **Student Eligibility List: Columns** screen allows you to add students to your list who indicated on their application that they were bilingual.
 - This selection does not automatically appear under the default selected column, it would need to be selected from the Unselected column and moved to the Selected.
 - This is true for any other selection in the Unselected column that you may want to show on your Student List Eligibility: View screen.
 - Once you have moved the Bilingual Application information to the selected column you can now select List at the bottom of the screen, and it will provide you with a new list of columns that show bilingual applicants.
 - Remember you can sort your list anyway that you want by using those Up and Down, Side to Side arrows.

- Schools may submit claims for the spring semester and winter quarter (second-term).
- The second-term priority claim deadline date will be announced once it has been determined.
- Fall (first-term) claims are still being accepted even though the deadline date was Friday, December 29, 2023
 - Any first-term claims made after the deadline date will be considered late and will only be paid if funding is available after paying timely claims.
- The Golden Apple Foundation only awards a student one term at a time
 - As a result, the award field in the GA system identifies the awards as Annual Award Amount To Date
 - For example: In the fall term, the Annual Award Amount To Date shows the fall term amount only, not the entire award year
 - If the same student is awarded for the spring term, the "Annual Award Amount To Date" will increase in the spring to include the second term award amount

Golden Apple Payment Adjustment

- If an adjustment is needed to increase or decrease an award:
 - A school can submit a request to increase/decrease up to the Annual Award Amount for the term
 - GAP Access will process the new payment request and will send an additional payment minus any previous funds paid if it is an increase
 - If it is a decrease, it will process that request and adjust the award accordingly
 - For Example: The annual award amount shown is \$2,500 for Term 1 and the school only requested \$1,250 for Term 1. A request can be submitted to increase the award up to the full annual award amount for Term 1.
 - GAP Access will process the additional request and remit payment for \$1,250 and increase the amount paid for the term to \$2,500.

Illinois National Guard (ING) Grant Programs

- Schools may submit benefit usage data for the spring term.
- The date by which the spring term benefit usage data must be submitted will be announced once it has been determined.
- Fall term benefit usage data can still be submitted even though to be considered timely was Friday, December 29, 2023.
 - Colleges are encouraged to report Fall term data as soon as possible.
- Starting with the 2023-24 academic year there are no longer term deadline dates by which applications must be submitted each term
 - However, applications must be received by ISAC in time for eligibility to be determined for the term
 - The applicant will need to notify the college about their eligibility no later than the last scheduled day of classes for the first term for which benefits will be requested


Just a reminder...

Prorating ING Grant benefits in a term is only completed if:

- The student will not have completed one full year of service in the Illinois National Guard after the semester has started, *or*
- If the student's active status with the Guard ends during a term.

To determine the benefit amount, determine the cost per day for the term:

 Calculation: Total tuition cost divided by total instructional days = cost per day x days of eligibility = total proration.

- Applicants must reapply each year
- Qualified applicants will be sent a Notice of Eligibility from ISAC
 - If application is incomplete, a Notice of Incomplete Application will be sent to the applicant



Post-Master of Social Work School Social Work Professional Educator License Scholarship Program (SWSP)

- Schools may submit claims for the spring term.
- Spring term priority claim deadline date will be announced once it has been determined.
- Fall claims are still being accepted even though the deadline date was Friday, December 29, 2023.
 - Any first-term claims made after the deadline date will be considered late and will only be paid if funding is available after paying timely claims.



Displaced Energy Worker Dependent Transition Scholarship

- Certification of Enrollment for Payment rosters for the fall term have been emailed to financial aid directors, initiating the payment process.
- Even though the deadline date has passed to return the rosters for the Fall term to ISAC, colleges that have not done so are encouraged to complete and submit the roster as soon as possible.
 - Deadline date was Thursday, November 30, 2023.
- The online application remains available in the ISAC Student Portal.
- Remaining application deadline dates for the award year are:
 - March 1, 2024 -- second semester (2nd/3rd Quarter) and summer consideration
 - $_{\circ}$ June 15, 2024 -- only summer term consideration
- Colleges are encouraged to promote availability and information about this program within their communities.



Community Behavioral Health Care Professional Loan Repayment Program

- Program administration for 2023-24 has taken place in GAP Access.
- Certification of applicants' employment status at community mental health facilities must be verified as part of program eligibility.

2024-25 MAP Start-up Formula

Each year the Illinois Student Assistance Commission (ISAC) is responsible for adopting an allocation formula for the Monetary Award Program (MAP). The Commission approves a "start-up" formula that is used to begin making award announcements for students applying for the next academic year. Typically, once the Governor and General Assembly take final action on the budget, the Commission revisits the formula in June or July and takes action to approve a "recompute" formula.

Unless otherwise noted, all calculations should be rounded to the nearest whole dollar upward from .500 and downward from .499. Students who have been paid for 135 or more MAP Paid Credit Hours are not eligible for MAP.

2024-25 Start-up Formula


On September 21, 2023, the Illinois Student Assistance Commission approved the 2024-25 (FY25) MAP start-up formula. Following the FY24 recompute formula, the start-up formula for 2024-25 MAP grants – which is outlined in Table One of Agenda Item 5 from the September 21, 2023 Commission meeting – uses:

- · the 2021-22 Pell Grant Payment Schedule;
- a \$5,200 living allowance; and,

2024-25 School-Issued Award Notification Language

All schools are required to announce MAP Grant awards to all eligible students enrolled at their institutions, including students who are only eligible for a second semester/second and third quarter MAP award. Schools are required to clearly identify the awards on the award notification as: **State of IL MAP Grant (Est)**.

Schools are also required to include the following information with the award notification:

By applying for financial aid and agreeing to share that information with the Illinois Student Assistance Commission (ISAC) you have been considered for the State of Illinois (IL) Monetary Award Program (MAP) Grant. All MAP-approved institutions are required by the State of Illinois to announce MAP Grant awards to students who are enrolled or intending to enroll at their institution. An award amount is included in your financial aid package if you have met the eligibility criteria.

The MAP Grant award amount is an estimate made by the financial aid office and is identified as a "State of IL MAP Grant (Est)". Please be aware that the number of available MAP Grants is limited by funding levels approved by the Illinois General Assembly and the Governor, and reductions to estimated or actual MAP Grants are possible.

There are also limitations to how long you can continue to receive a MAP Grant. Usage is tracked by the number of credit hours for which you've received MAP benefits and is referred to as MAP Paid Credit Hours (MPCHs). The maximum number of MPCHs that can be received is 135, which is equivalent to approximately four and a half years of full-time enrollment. For your reference, and to learn more about MPCH limitations, you may access a record of your MPCHs, as well as other student resources, through the ISAC Student Portal at <u>studentportal.isac.org</u>.

Eligibility for the need-based MAP Grant award may indicate that you are eligible for assistance with expenses such as food, housing, or child care for dependent children. If you have dependent care expenses, ask the financial aid office about the federal dependent care allowance. For eligibility and application information about the <u>Supplemental Nutrition Assistance Program</u> (SNAP) and the <u>Child Care Assistance</u> <u>Program</u>, contact the <u>Illinois Department of Human Services</u> at **800-843-6154** or <u>www.dhs.state.il.us</u>. Contact the <u>Illinois Hunger Coalition</u> Hunger Hotline at **800-359-2163** or <u>www.ilhunger.org</u>.

MAP 160-Byte File Layout Specifications

- The final file layout for 2024-25 MAP processing has been posted to the Electronic Tools section of the E-Library
- For 2024-25, these data elements are no longer included on the file:
 - Student Social Security number (SSN)
 - Student Last Name (previously an optional field)
 - Original SSN
 - Name ID
- These Personally Identifiable Information (PII) data elements were removed to protect student identity when transmitting files between ISAC and colleges
- The student's Person Universally Unique Identifier (UUID) that is assigned to the student by the Department of Education (ED) by the FAFSA Processing System (FPS) will replace the SSN on the file
 - The Person UUID field is 36 characters in length, and the total number of characters being removed is also 36, so the length of the file will not change
 - The Person UUID will stay the same for the student across FAFSA cycles
 - ISAC will generate and a Person UUID for Alternative Application applicants



NES Program

- Application period will be March 1 through April 30, 2024
 - An application must be completed and submitted each year to be considered for an award, regardless of whether the student may have received previous awards
 - The NES Application/Grant Agreement/Promissory Note must also be submitted to ISAC on or before April 30, 2024
 - Applicant must submit a 2024-25 FAFSA or Alternative Application and have a valid Student Aid Index (SAI) calculated


