

## ***2019-20 SETTW Verification Roster*** **Instructions and Column Descriptions**

<b>Column Headings</b>	<b>Descriptions</b>												
<b>Name</b>	Student's last name, followed by student's first name and middle initial. Students are listed in alphabetical order.												
<b>SSN</b>	Student's Social Security Number (SSN). Any changes to the SSN must be submitted to ISAC in writing. The student and/or the school can submit changes to the SSN using the student's SSN card as documentation.												
<b>Type</b>	<p>HS - High School T - Teacher</p> <p>250 waivers are awarded annually. 210 waivers are awarded to high school graduates pursuing initial teacher certification in a special education discipline. 40 waivers are awarded to certified teachers pursuing initial teacher certification in a special education discipline. This column, using the above codes, categorizes your student population between the two groups. The last page of your roster provides a total count of student recipients.</p>												
<b>Disqualified Codes</b>	<p>If a recipient is ineligible for the SETTW award, use one of the following disqualified codes to indicate the reason.</p> <p>1 - The recipient did not enroll within ten days after the beginning term, which ISAC initially awarded the waiver.</p> <p>2 - The recipient is enrolled at this school but is not seeking an initial Special Education teacher certification.</p> <p>3 - The recipient transferred to another eligible school.</p> <p>4 - The recipient accepted the Minority Teachers of Illinois (MTI) Scholarship rather than the SETTW.</p> <p>5 - The recipient declined the tuition waiver.</p> <p>6 - The recipient is not an Illinois resident.</p> <p>7- The recipient is not a United States citizen or an eligible noncitizen</p> <p>8. The recipient is not making satisfactory academic progress</p>												
<b>Applied for MTI</b>	If ISAC has record that a student has applied for the Minority Teachers of Illinois (MTI) scholarship, this will be indicated in this column. Also, this indicator will not reflect information that may have been provided by the school on the <i>Initial Certification Form</i> for the teacher scholarship programs.
