“Even with the rising costs of tuition, college can be possible if families start planning early, with what they can afford,” said Eric Zarnikow, executive director of the [Illinois Student Assistance Commission](#), the state’s college access agency and administrator of the College Illinois! Families can purchase anywhere from a semester of community college all the way up to nine semesters at a public university in the state.
